SMHC TEAM RULES

Summer Madness Hoops Classic Team Rules

1. The National High School Federation Rules and Regulations (NHSF) will apply to all USSSA games with the following exceptions.
2. All games will be played as follows:
 - **11U and 12U:** Two 14-minute halves, 28.5 intermediate-size ball.
 - **13U - 15U:** Two 16-minute halves, regulation-size basketball.
 - No game will start before the scheduled time unless both coaches agree. There will be a minimum of a 5-minute warm-up period. Halftime will be 5 minutes unless both coaches agree to start earlier.
 - Timeouts will be awarded under NHSF rules (3 Full/2 Thirty Second)
 - **Overtime:**
 - » 11U and 12U: 3 minutes
 - » 13U - 15U: 4 minutes
 - The clock will stop for all whistle stoppages ONLY in the championship games
 - Two (2) direct technical fouls during a game on a player, coach, or team representative will result in their ejection from that game and the next game of the tournament. Fighting and gross, unsportsmanlike behavior can be more than one game and is at the discretion of the Tournament Director.
 - Suspensions from USSSA-sanctioned activities shall be governed by the USSSA Constitution.
 - Each team is responsible for their warm-up balls and other items brought into the game. MIB is not responsible for lost items.
 - MIB will provide game balls.
 - If a team forfeits two games by not participating, the team will be disqualified from the event and cannot participate in bracket/tournament play.



SMHC CODE OF CONDUCT & RULES

All players and coaches will demonstrate good sportsmanship to all participants, fans, officials, and staff.

1. No drugs or alcohol will be permitted for any event or facility.
2. No team(s) or coach(s) will receive a refund if you cancel less than two weeks before the event or the team does not show up for their scheduled game time.
3. Coaches will be held responsible for the conduct of their players and fans. Any fans removed because of misconduct will not be allowed back in for the remainder of the tournament.
4. The roster is set upon final submission no later than November 11, 2026. No additions to the rosters will be permitted without prior approval by the Tournament Director.
5. All players and coaches should ensure that their team is in good health before participating in the tournament.
6. All players and coaches will treat players, other coaches, officials, event staff, and fans respectfully, regardless of race, sex, and ability.
7. All players and coaches will refrain from vulgar, lewd, or obscene language or gestures while participating in tournaments or watching any games or tournament events.
8. All players, coaches, and their fans will not deface any part of the facilities or property where any event affiliated with the MyIsland Ballers is held.

PROTEST

All roster protest must be filed in writing accompanied by a \$100.00 protest fee (refundable if the protest is valid) with the Tournament Director within one (1) hour of the conclusion of the protested game. If the protest is valid, the protested team forfeits all previous games. Upon protest, teams must provide proof of eligibility. (See roster rules for acceptable proofs of age and grade).

PROTEST CONT.

- All non-roster protest must be filed in writing within one (1) hour of the conclusion of the contest and must be accompanied by a \$100.00 protest fee (refundable if protest is upheld). Official's calls are not grounds for a protest.
- Tournament Directors rulings on protest are final.

MERCY RULE

Once a team is leading by 30 points anytime in a game, the clock will continue to run. The only time the clock will stop is for injuries or timeouts. If the lead falls below 20 points, the clock will again be stopped for all whistle stoppages.

TIE-BREAKERS

- Two Teams Tied: Head-to-head result.
- Three or more teams: Point Differential System will be used. Teams will receive a point differential per game up to a maximum of plus 15 points for a win and a maximum of minus 15 points for loss.

The team not involved in the tiebreaker will have its games eliminated. The team with the highest point total will win the tiebreaker, and the second-highest number will be seeded second, etc. If two teams are tied with points, then revert back to head-to-head. If there are still three teams tied, the team with the fewest points allowed in ALL games played in pool play wins. A forfeit is scored as a 15-0 game.
